Dear Mr. Fox:

A fingerprint search conducted through the New Jersey State Police and the Federal Bureau of Investigation in accordance with N.J.S.A.18A:6-7.1 et seq., or N.J.S.A.18A:6-4.13 et seq., has revealed the following information contained in the attached Addendum A.

Pursuant to the above-cited statutes, you are permanently disqualified from employment in any position with a school or other educational institution under the supervision of the Department of Education or with a contracted service provider under contract with said school or educational facility. You have 30 days from the date of this written notice of disqualification to challenge the accuracy of your criminal history record. You must submit documentation from the respective courts to support your claim of an error in the criminal record. If the crime or offense can be expunged and the period of time required by statute has passed, you may re-apply for school employment upon completion of that process.
